If the Executive Director of the Bighorn River Alliance determines that it is not feasible or economical to use the gift for the purpose stated above, the gift may be used for such exempt purposes of the Bighorn River Alliance as the Board of Directors directs."

"I give, devise and bequeath to the Bighorn River Alliance, a nonprofit organization organized and existing under the laws of the State of Montana, Tax ID 36-5177006, the sum of \$\_\_\_\_\_ in cash or in-kind (or \_\_\_\_\_ shares of \_\_\_\_\_ stock) to be used at the discretion of the BHRA Board of Directors for the mission of the Bighorn River Alliance."

#### **Gift of a specific amount for a specific purpose to the Bighorn River Alliance**

"I give, devise and bequeath to the Bighorn River Alliance, a nonprofit organization organized and existing under the laws of the State of Montana, Tax ID 36-5177006, the sum of \$\_\_\_\_\_ (or \_\_\_\_\_ shares of \_\_\_\_\_ stock) to be used for \_\_\_\_\_. If circumstances should at some time in the future make it impractical to continue using the income from this gift for the purpose designated, then the Bighorn River Alliance Board of Directors may re-designate the purpose to adhere as closely as possible to my original intent."
